Our mission is to lessen the trauma experienced by child victims when abuse allegations are investigated and to provide support during any subsequent proceedings within the criminal justice system.

The Baton Rouge Children's Advocacy Center is dedicated to assisting the various needs of child victims of sexual or severe physical abuse. The center provides a safe, child-friendly environment, where comprehensive interviews are conducted. This service is essential to reducing the number of times a child will have to relive the trauma of the abuse.

We also provide at no cost to the family, trauma focused therapy to the child victim and non-offending caregivers. This treatment approach is shown to help children, adolescents, and their caretakers overcome trauma-related difficulties. It is designed to reduce negative emotional and behavioral responses following child sexual abuse and other traumatic events.
